GENERAL INFORMATION: PRE-BID MANDATORY MEETING

1. Q – Is a Contractor’s License required for this project that will be priced over \$30,000.00
A –Landscape Contractors’ Licensing will not be required for this Informal Service. Under General Statute 89D-13.11(f), Landscape Contractor Licensure, Exemptions: The provisions of this Chapter shall not apply to the following: An individual or a business engaged in any of the following activities while performing that activity: (f) Lawn mowing, turf edging, and debris removal services.
2. Q – Is this contract for only 1 year?
A – The award is for approximately 36 mows within a one year contract period. The purchase order issuance date will be the start date of the contract.
3. Q – Are we to put the price per mow on the list of site addresses lines?
A – Yes, record the your bid as **cost per mow, per site**. Remember to tally and write in total cost at the bottom of ATTACHMENT A.1 form and **also place on** the signed terms and conditions sheet.
4. Changes to bid sites per Walk Through on Wednesday, July 22, 2020. Take note of the changes and use ATTACHMENT A.1 in place of the original sheet to submit with the signed contract terms acceptance sheet.
 1. Tax Office and Library will be priced as one site.
 2. Remove Sheriff from the bid site. Only bid for Tradd Street Building.
 3. Include Jail Detention Center, scope of work is the slop area and surrounding areas around parking lot areas to the end of Tradd Street.
